

• The Quarter Heads of Muwachu, Alachu and Matsam.  
**Article 4:** The President shall, if necessary and based on required competences, co-opt any other person(s) to take part in the work of the Commission.

**Article 5:** The functions of the President and members of the Commission are free of charge. However, work facilities shall be given to those concerned as well as to persons invited in conformity with the regulations in force.

**Article 6:** The Commission which shall meet upon invitation of the President shall submit its report within a maximum period of **one (01) week**.

**Article 7:** This Decision shall be registered and communicated wherever need be.

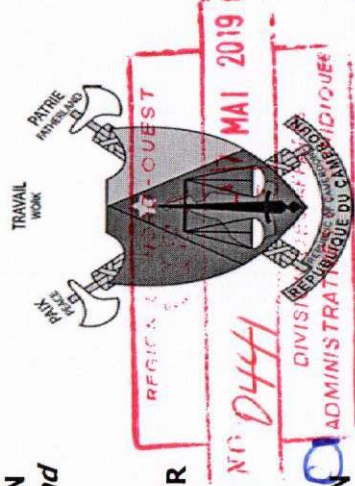

Mindful of the constitution;

Mindful of law N° 73/12 of the 7<sup>th</sup> of December 1972 bearing on the general organization of civil protection;

Mindful of Decree No. 2008/376 of 12/11/2008 on the Administrative Organization of the Republic of Cameroon;

Mindful of Decree No. 2008/377 of 12/11/2008 defining the attributes of Heads of Administrative Units and the organization and functioning of their services;

Mindful of Decree No. 2012/109 of 14/03/2012 appointing Mr. LELE LAFRIQUE TCHOFFO DEBEN Adolphe, Governor of the North West Region;

Considering the necessity of service;

**HEREBY DECIDES AS FOLLOWS:**

**Article 1:** With effect from the date of signature of the present Decision, a commission to evaluate property damaged at Muwachu, Alachu and Matsam in Mankon as a result of the incident of Wednesday the 15<sup>th</sup> of May 2019.

**Article 2:** The commission shall, particularly, be charged with the following:

- evaluation of the humanitarian situation,
- identification of all the victims and their needs,
- ascertain material damages and property destroyed.

**Article 3:** The composition of this Commission shall be as follows:

**President:** The Senior Divisional Officer for Mezam

**Rapporteur:** The Regional Delegate of State Property, Surveys and Land Tenure

**Members:**

- The Divisional Officer of Bamenda II Sub Division
- The Commander of the Army Rescue Unit Bamenda.
- The Divisional Delegate of the Environment, Nature Protection and Sustainable Development
- The Divisional Delegate of Agriculture and Rural Development for Mezam
- The Divisional Delegate of Trade for Mezam
- The Divisional Delegate of Social Affairs for Mezam
- The Divisional Delegate of Urban Development and Housing for Mezam
- The Mayor of Bamenda II Council
- The Fon of Mankon or his Representative
